## Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of December, 2022.

#### I. Swachh Bharat Mission

- i. All 4,715 cities/ towns have been declared as ODF (Open Defecation Free) of which 4,355 cities have been certified through third party verification, 3,547 cities have been certified as ODF+, 1191 cities have been certified as ODF++ and 14 cities (Indore, Surat, New Delhi Municipal Council (NDMC), Tirupati, Chandigarh, Navi Mumbai, Vijayawada, Hyderabad, Greater Visakhapatnam, Karad, Panchgani, Bhopal, Baramati and Mysore) have been certified as Water+.
- ii. 67,407 toilets across more than 3,326 cities are live on Google Maps with the name of "SBM Toilet".
- iii. Swachhata App emerged as an important tool towards enabling citizens to have their grievances addressed by the concerned Municipal Corporation. The Swachhata App has a total of 2.08 crore users, who have posted 2.55 crore complaints, of which 2.39 crore complaints have been resolved, with a resolution of above 94%.
- iv. The result of GFC2022 was declared on 01st October 2022 as part of the Swachh Survekshan Award Ceremony 2022. The number of cities with 7-Star Certification is 1, 5-Star Certification is 11, 3-Star Certification is 199 and 1-Star Certification is 234 under Star Rating Protocol for Garbage Free Cities(GFC).
- v. Virtual Conference with Chief Secretaries on Circular Economy held on 23rd December 2022. The event was graced by Shri Rajeev Gauba, Cabinet Secretary and Shri. P.K. Mishra, Principal Secretary to the Hon'ble PM. The meeting was also attended by Chief Secretaries from various States, ACS/ Principal Secretaries, Mission Directors, and Commissioners of Million Plus cities of various States and Secretaries of various Ministries.
- vi. In the 7<sup>th</sup> Meeting of National Advisory and Review Committee (NARC) for SBM-U held on 21st December 2022, Action plans worth Rs. 2,500+ Cr were approved for 12 States (Uttar Pradesh, Telangana, Jharkhand, Madhya Pradesh, Ladakh, Meghalaya, Manipur, Kerala, Karnataka, Punjab, Arunachal Pradesh, and Rajasthan) to solidify Solid Waste Processing Facilities, Used Water Management facilities, capacity building, and IEC components under SBM-U 2.0.

### II. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

i. State Annual Action Plans (SAAPs) have been finalized for all the states for ₹77,640 crore. As on date, Detailed Project Reports (DPRs) have been approved for the projects costing ₹82,640 crore. Some States have taken up projects in excess of their approved SAAPs. Entire excess amount in such cases will be borne by the States/ULBs. Works have been completed for 4,720

projects worth ₹33,381 crore and work is in progress for 1,155 projects worth ₹48,864 crore. In all, physical work worth about ₹67,371 crore has been carried out in completed/ongoing AMRUT projects implying that around 87% of physical work has been completed.

ii. So far, ₹37,533 crore has been released to States/UTs towards project implementation (including the eligible projects of erstwhile JnNURM), Administrative & Office Expenses (A&OE), reform incentive, and under subschemes on 'Formulation of GIS based Master Plans in AMRUT cities' and 'Local Area Plan (LAP) and Town Planning Schemes (TPS)' in 25 selected cities.

## III. Deendayal Antyodaya Yojana /National Urban Livelihood Mission (DAY/NULM)

'10,913 Self Help Groups (SHGs) have been formed; 11,705 SHGs were given Revolving Fund; 23,347 candidates were skill trained and certified; 8,466 trained candidates were given placement; 10,176 beneficiaries were assisted with loans for setting up of individual and micro enterprises and 23,368 loans were given to SHGs under SHG-Bank linkage programme.

#### IV. PM Street Vendor's Atma Nirbhar Nidhi (PMSVANidhi)

- i. Under PM Street Vendor's AtmaNirbhar Nidhi (PMSVANidhi), 60,31,809 applications have been received against which 45,21,149 sanctions and 38,93,332 disbursals have been made.
- ii. A total of ₹80.01 crore have been released under the mission during the month of December, 2022.

### V. Pradan Mantri Awas Yojana (PMAY)/Housing for All (HFA)

- i. Since the inception, Mission has sanctioned 1.23 crore houses of which 107.30 lakh houses have been grounded for construction of which 67.10 lakh houses have been completed/delivered.
- ii. A total of ₹7483.99 crore have been released under the PMAY mission during the month of December, 2022.

#### VI. Housing

- i. All States/ UTs have notified rules under RERA except Nagaland, which is under process to notify the rules.
- ii. 32 States/UTs have set up Real Estate Regulatory Authority (Regular 26, Interim 06). Ladakh, Meghalaya, Sikkim have notified the rules while yet to establish authority.
- iii. 28 States/UTs have set up Real Estate Appellate Tribunal (Regular -24, Interim 04). (Arunachal Pradesh, Jammu & Kashmir, Ladakh, Meghalaya, Mizoram, Sikkim and West Bengal are under process to establish).

- iv. Regulatory Authorities of 28 States/UTs have operationalized their websites under the provisions of RERA (Arunachal Pradesh, Jammu & Kashmir and Manipur are under process to operationalize).
- v. So far, 1,05,731 complaints (including 2,115 complaints during the month) have been disposed of by the Real Estate Regulatory Authorities across the country
- vi. So far, 1,00,166 projects and 73,090 agents have been registered under RERA. 1,880 projects and 1,352 agents have been registered during the month.
