Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of September, 2022

I. Swachh Bharat Mission

- i. All 4,372 cities/ towns have been declared as ODF (Open Defecation Free) of which 4,325 cities have been certified through third party verification, 3,447 cities have been certified as ODF+, 1062 cities have been certified as ODF++ and 14 cities have been certified as Water+.
- ii. 67,407 toilets across more than 3,326 cities are live on Google Maps with the name of "SBM Toilet".
- iii. The result of GFC 2022 was declared on 01st October 2022 as part of the Swachh Survekshan Award Ceremony 2022. This year total 261 ULBs are GFC certified, increasing the number of one-time certified cities to 445 with 1 city as 7-Star, 11 cities as 5-Star, 199 cities as 3-Star and 234 cities as 1-Star.
- iv. Hon'ble Union Minister Shri Hardeep Singh Puri announced the commencement of the "Swachh Amrit Mahotsav", a fortnight of activities to galvanize action around swachhata from 17th Sept. 2022, Seva Diwas, till 2nd Oct. 2022, Swachhata Diwas to celebrate eight years of Swachh Bharat Mission-Urban. The fortnight focused on mobilizing citizen action and commitment towards the vision of building "Garbage Free Cities". He also released the official logo for the fortnight, "Swachh Amrit Mahotsav: Ek Aur Kadam Swachhata Ki Ore" signifying the resolve to intensify and reinvigorate the Jan Andolan in the world"s largest sanitation programme.
- v. Swachh Bharat Mission-Urbans efforts towards transforming cities to become garbage free received a fresh impetus. SBM-Urban 2.0"s maiden edition of "Indian Swachhata League (ISL)" has successfully mobilized half a million young students, citizen volunteers, youth leaders, and celebrity icons across the country towards the Mission's goal of making cities clean, green, and garbage free.
- vi. Ministry of Housing and Urban Affairs (MoHUA) took a step towards achieving circularity in toy sector. Secretary, MoHUA launched the Swachh Toycathon by unveiling the online platform on MyGov portal and releasing the toolkit. Under the National Action Plan for Toys, Swachh Toycathon was launched, a competition for new ideas to transform waste into toys. The competition seeks to explore solutions for use of waste in creation or manufacturing of toys.

II. Smart Cities Mission (SCM)

i. During the month 356 projects worth ₹ 11,409 crore have been completed, work has been started on 36 projects worth ₹ 1,820 crore. So far 7,709 projects worth ₹1,81,488 crore have been grounded and 4,820 projects worth ₹ 90,015 crore have been completed.

III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

- i. State Annual Action Plans (SAAPs) have been finalized for all the states for ₹77,640 crore. As on date, Detailed Project Reports (DPRs) have been approved for the projects costing ₹82,924 crore. Some States have taken up projects in excess of their approved SAAPs. Entire excess amount in such cases will be borne by the States/ULBs. Works have been completed for 4,588 projects worth ₹31,622 crore and work is in progress for 1,270 projects worth ₹50,738 crore. In all, physical work worth about ₹65,593 crore has been carried out in completed/ongoing AMRUT projects implying that around 84% of physical work has been completed.
- ii. So far, ₹37,493 crore has been released to States/UTs towards project implementation (including the eligible projects of erstwhile JnNURM), Administrative & Office Expenses (A&OE), reform incentive, and under subschemes on 'Formulation of GIS based Master Plans in AMRUT cities' and 'Local Area Plan (LAP) and Town Planning Schemes (TPS)' in 25 selected cities.
- iii. 'City- Startup Partnership Summit for Water Security' was organised by MoHUA on 09.09.2022 at Vigyan Bhawan, New Delhi.

IV. Deendayal Antyodaya Yojana /National Urban Livelihood Mission (DAY/NULM)

- i. 12,782 Self Help Groups (SHGs) have been formed; 10,445 SHGs were given Revolving Fund; 25,982 candidates were skill trained and certified; 3,883 trained candidates were given placement; 14,858 beneficiaries were assisted with loans for setting up of individual and micro enterprises and 17,885 loans were given to SHGs under SHG-Bank linkage programme.
- ii. A total of ₹784.80 lakh have been released under the DAY-NULM Scheme during the month.

V. PM Street Vendor's AtmaNirbhar Nidhi (PMSVANidhi)

i. Under PM Street Vendor's AtmaNirbhar Nidhi (PMSVANidhi), 56,66,391 applications have been received against which 39,55,222 sanctions and 35,89,378 disbursals have been made.

VI. Pradan Mantri Awas Yojana (PMAY)/Housing for All (HFA)

 Since the inception, Mission has sanctioned 1.23 crore houses of which 104.12 lakh houses have been grounded for construction of which 63.27 lakh houses have been completed/delivered.

ii. A total of ₹6,975.21 crore have been released under the PMAY(U) mission during the month.

VII. Housing

- i. All States/ UTs have notified rules under RERA except Nagaland, which is under process to notify the rules.
- ii. 31 States/UTs have set up Real Estate Regulatory Authority (Regular 25, Interim 06). Ladakh, Meghalaya, Sikkim & West Bengal have notified the rules while yet to establish authority.
- iii. 28 States/UTs have set up Real Estate Appellate Tribunal (Regular -24, Interim 04).
- iv. Regulatory Authorities of 28 States/UTs have operationalized their websites under the provisions of RERA.
- v. So far, 1,00,187 complaints (including 553 complaints during the month) have been disposed of by the Real Estate Regulatory Authorities across the country
- vi. So far, 93,984 projects and 69,218 agents have been registered under RERA. 1,892 projects and 855 agents have been registered during the month.
