Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of November, 2019

I. Swachh Bharat Mission

- i. 1.57 crore citizens are registered on the Swachhata App, 1.79 crore complaints have been registered out of which more than 93% complaints have been resolved.
- ii. On Swachh Bharat Helpline (1969), for all issues related to Swachh Bharat, 5.09 lakh+ calls have been answered with an average handling time of 1 minute 28 seconds.
- iii. A total of 4,320 cities/ towns has been declared as ODF (Open Defecation Free), 739 cities have been certified as ODF+ and 292 cities have been certified as ODF++.
- iv. 57,000 toilet across 2,500+ cities are live on Google Maps with the name of "SBM Toilet" covering 55% of urban population.
- v. 114 cities have been registered on Swachh Nagar Mobile App so far.
- vi. As on date 8,500 Garbage Vulnerable Points (GVP) have been mapped, out of which 950 are being monitored. 360 cities comprising of 2,150 active wards are using this module. The Swachh Survekshan 2020 has a dedicated indicator on monitoring and transformation of GVPs.
- vii. Under Protocol for Star rating of Garbage Free cities, four cities have got 5-star certification, 57 cities have got 3-star certification and 4 cities have got 1-star certification.
- viii. A review cum consultation workshop was organized on 5 November, 2019 to review the performance of West Bengal under Swachh Bharat Mission (Urban) and 330 participants attended the workshop. During the workshop, many key presentations were made including on ODF status of Urban Local Bodies, Swachh Bharat Mission (Urban) protocols, facilities from National Safai Karamcharis Finance and Development Corporation, Sanitation status of Ganga Towns and Emergency Response Sanitation Units (ERSUs) .
- ix. Delegates from the IVL Swedish Environmental Research Institute visited MoHUA for a presentation on technologies pertaining to co-digestion, biomethanation technologies, wastewater management and treatment and solid waste management technologies feasible for the Indian context. It is intended to collaborate with IVL Swedish Environment Research Institute and extend this cooperation to States and Urban Local Bodies (ULBs) for effective waste management.
- x. A Joint Declaration of Intent regarding the cooperation in the field of prevention of marine litter was signed during recently concluded 5th Inda-

German Governmental consultation in New Delhi. Subsequently, the agreed minutes of German Appraisal Mission for bilateral cooperation project on 'Cities Combating Plastic Entering the Marine Environment' were signed between MoHUA and GIZ (German Corporation for International Cooperation).

xi. National Institute of Urban Affairs (NIUA) is conducting a series of Swachh Bharat Mission (Urban) Exposure Workshops in 26 locations for the period of October to December, 2019. The purpose of the SBM (Urban) Exposure Workshops is to recognize the issues, challenges and constraints of Solid Waste Management (SWM), promote awareness regarding the various approaches, technologies and their financial implications through demonstrations, mainstreaming of sanitary workers including informal workers, conduct exposure field visits, and discuss case studies of citizens' engagements in waste management. 250 ULBs have participated with 400 participants in the 10 workshops.

II. Smart Cities Mission

- i.Work has been completed in 42 projects worth Rs. 914 crore, work was started for 73 projects worth Rs. 280 crore and tendering was issued for 63 projects worth Rs. 1,147 crore. With this, 4,231 projects worth Rs. 1,50,140 crore have been tendered, work orders have been issued for 3,451 projects worth Rs. 1,06,119 and 1,327 projects worth Rs. 23,480 crore have been completed.
- ii.The Smart Cities Mission organized an "Implementathon" for providing handholding support to cities which have demonstrated less than expected performance in project implementation. 19 Smart Cities participated in this event organized at Panaji on 8th November, 2019.

III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

- i.State Annual Action Plans (SAAPs) to the tune of Rs. 77,640 crore have been approved for all the States. Out of these, works have been awarded for projects worth Rs. 71,452 crore including completed projects worth Rs. 7,178 crore. Remaining projects are under various stages of tendering and Detailed Project Report (DPR) for approval.
 - ii. So far, Rs. 23,804 crore has been released to States/UTs towards project implementation, Administrative & Office Expenses, reform incentive and for formulation of GIS based Master Plans & Local Area Plan (LAP) and Town Planning Schemes (TPS).

IV. Deendayal Antyodaya Yojana / National Urban Livelihood Mission (DAY/NULM)

- i.A total of Rs. 41.21 crore has been released during the month.
- ii.9,570 Self Help Groups (SHGs) were formed, 6,931 SHGs were given Revolving Fund, 14,154 candidates were skill trained and certified, 8,638

trained candidates were given placement, 10,802 beneficiaries were assisted with loans for setting up of individual and micro enterprises and 16,996 loans were given to SHGs under SHG-Bank linkage programme.

V. Pradan Mantri Awas Yojana (PMAY)/ Housing for All (HFA)

- i. Out of Rs. 1.51 lakh crore Central assistance approved, A total of Rs. 57,896 crore has been released under the Mission.
- ii. So far the Mission has achieved the milestone of sanctioning more than 96.50 lakh houses against the validated demand of 1.12 crore houses. 56 lakh houses have been grounded for construction of which 28.4 lakh houses have been completed. The investment in sanctioned houses is Rs. 5.7 lakh crore which includes Rs. 2.9 lakh crore as Public Sector investment while Rs. 2.8 lakh crore is coming from Private Sector.
- iii. The Credit Link Subsidy Scheme (CLSS) Awas Portal (CLAP) was launched, which is transparent & real-time web-based system wherein, all stakeholders are integrated.
- iv.The proposal for construction of 3,31,075 houses with an overall investment of Rs. 15,125 crore involving central assistance of Rs. 5,092 crore was approved for the states of Andhra Pradesh, Karnataka, Madhya Pradesh, Gujrat, Maharashtra & Uttarakhand. This also includes 6 Light Houses Projects (LHP) for construction of 6,368 houses to be built in Gujarat, Jharkhand, Madhya Pradesh, Tamil Nadu, Tripura and Uttar Pradesh.
- v.The inclusion of financial literacy in ANGIKAAR campaign to build the capacities of PMAY (U) beneficiaries through outreach camps by Banks/ PLIs was announced.

VI. Housing

- i.30 States/ UTs have notified rules under RERA; 4 North Eastern States namely Arunachal Pradesh, Meghalaya, Nagaland and Sikkim are under process to notify the rules under RERA.
- ii.29 States/UTs have set up Real Estate Regulatory Authority (Regular 22, Interim 07).
- iii.24 States/UTs have set up Real Estate Appellate Tribunal (Regular -14, Interim 10).
- iv.Regulatory Authorities of 24 States/UTs have operationalised their websites under the provisions of RERA.
- v.904 projects and 743 agents have been registered in month of November, 2019 across the country. So far, 47,102 projects and 37,164 agents have been registered under RERA.

VII. NBCC

- i.A revised MoU was signed between NBCC (India) Ltd. And Rail Land Development Authority (RLDA) for re-development of railway stations pan India.
- ii.NBCC (India) Ltd. signed an MoU with Government of Andhra Pradesh for monetizing the vacant land parcels in the State and implementing the Govt. of Andhra Pradesh's Flagship Programmes including infrastructure work across the state utilizing the funds generated out of commercial exploitation of land.
