- The funds shall be utilized for the purpose for which these are sanctioned; otherwise vi. these will have to be refunded along with interest as per provisions for GFR-2017.
- Transfers of funds to different entities and individual beneficiaries shall be made through vii. PFMS/DBT, as applicable.

Release of the Grant may kindly be made to the State Government immediately. The 4. funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
