- ii. The UT Government and implementing agency shall put in place a monitoring system to ensure that the project(s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- iii. The UT Government shall utilize the grant in accordance with the approved guidelines for the implementation of the Scheme of PMAY HFA (Urban) Mission.
- iv. The UT Government shall furnish the Utilization certificates of the Grant released in the prescribed format as per GFR 2017 as provided in the scheme guidelines.
- v. The funds may be utilized for the purpose for which these are given. Otherwise these will have to be refunded along with interest as per provisions under GFR 2017.
- vi. Where there is an element of cash transfer to individual beneficiaries, the same may be made through PFMS/DBT mode as applicable. The UT Govt. shall submit an authenticated certificate from the bank showing complete details of disbursement of funds to each beneficiary before release 2nd instalment.

- vii. The UT Government will be required to certify that the specifications of the houses conform to NBC Standards and that requisite infrastructure will be provided by the UT Government/ULB.
- viii. The UT Govt. shall submit the report of Third Party Quality Monitoring Agency (TPQMA) selected by UT for quality monitoring purpose before release of 2nd instalment.
- 4. Payment may kindly be made to the UT Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the UT Government with interest for the period of default.
