- i. Reimbursement of Rs. 291.505 lakh (Rupees Two Crore Ninety One Lakh Fifty Thousand and Five Hundred Only) for establishment of 1 State Level Technical Cell (SLTC) with 8 Specialists and 34 City Level Technical Cells (CLTCs) with 82 Specialists for the FY 2018-19 under PMAY(U) Mission during FY 2017-18; and
- ii. Rs. 163.350 Lakh (Rupees One Crore Sixty Three Lakh and Thirty Five Thousand Only) for 1st instalment of Central Assistance for establishment of 1 State Level Technical Cell (SLTC) with 8 Specialists and 34 City Level Technical Cells (CLTCs) with 82 Specialists for the FY 2018-19 under PMAY(U) Mission.

3. The above grant is subject to the following conditions:
- i. The State will comply with the terms and conditions stipulated in the PMAY(U) guidelines, CSMC directions and instructions issued by this Ministry.
 - ii. The States are requested to establish the SLTC/ CLTCs at the earliest under intimation to this Ministry.
 - iii. The State will utilize the sanctioned grant for the purpose for which it is released. The State Government/Nodal Agency shall furnish physical and financial progress reports every quarter.
 - iv. Further instalment of funds will be considered on receipt of expenditure statement/UC from the State Government along with details of specialists engaged subject to financial norms approved by 1st CSMC as well as adherence to scheme guidelines, furnishing clarifications/supporting documents and submission of pending UCs under RAY, if any.
 - v. State Government is required to furnish Utilization Certificate as per GFR, Undertakings and Statement of Expenditure to the Government of India as per Capacity Building Guidelines before claiming next instalment on utilization of 70% of the amount released earlier.
 - vi. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work. All bills/ voucher etc. should be safely kept at SLNA level for future audit and other references.
 - vii. The amount of central assistance approved will form a part of capacity building plan of the State under PMAY-HFA(Urban) mission.
 - viii. Transfer of funds, may be made through PFMS/DBT mode, as applicable.


