Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of May, 2019

I. Swachh Bharat Mission

- i. 1.50 crore citizens are registered on the Swachhata App, 1.70 crore complaints have been registered out of which 90% complaints have been resolved by end of this month.
- ii. Rs. 201.32 crore has been released to the States during the month.
- iii. On Swachh Bharat Helpline (1969), for all issues related to Swachh Bharat, more than 4.80 Lakh calls have been answered with an average handling time of 1 minute 27 seconds.
- iv. 'Swachh Manch' is the citizen engagement platform where 1,03,054 events are posted, 2 crore people participated and 2,430 ULBs are on board.
- v. 45,000 toilet blocks across 1,700 cities are live on Google Maps with the name of "SBM Toilet".
- vi. The Government of the Netherlands, Financial Inclusion Improves Sanitation and Health (FINISH) Society and WASTE Netherlands (an international organisation based in Netherlands in field of Sustainable Waste Management) brought together stakeholders for a round table discussion on 'Sanitation in the Circular Economy' in New Delhi on 24 May, 2019. The issues regarding the sanitation sector and the commitment of the Swachh Bharat Mission (Urban) was addressed at the session to provide a holistic and sustainable solution to the problem.

II. Smart Cities Mission

- i. Work had been completed in 6 projects worth Rs. 174 crore, work was started for 9 projects worth Rs. 187 crore and 23 projects worth Rs 551 crore have been tendered. With this, 868 projects worth Rs. 14,645 crore have been completed, 1,894 projects worth Rs. 72,866 crore are currently under implementation and 770 projects worth Rs. 45,460 crore are under tendering.
- ii. **IIT-H launches testbed to develop low carbon transport models:** The Indian Institute of Technology (IIT) Hyderabad has launched the 'M2Smart Testbed' which will be used to collect and process the traffic data through sensing technologies. This collected data will help develop low carbon models for Indian transport. M2Smart (Smart Cities for Emerging Countries based on Sensing, Network and Big Data Analysis of Multimodal Regional Transport System) is a joint project under the Science and Technology Research Partnership for Sustainable Development Program between India and Japan.

III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

- i. State Annual Action Plans (SAAPs) to the tune of Rs. 77,640 crore have been finalized for all the States. Detailed project reports for projects costing

Rs. 80,123 crore have been approved. 1,586 projects worth Rs. 4,060 crore have been completed, contracts have been awarded for 3,311 projects worth Rs. 60,253 crore and 344 projects worth Rs. 8,878 crore are under tendering and DPRs worth Rs. 8,515 crore are under preparation.

ii. So far, Rs.19,072.91 crore has been released to States/UTs towards project implementation, Administrative & Office Expenses, Reform Incentive and for formulation of GIS based Master Plans.

IV Deendayal Antyodaya Yojana / National Urban Livelihood Mission (DAY/NULM)

i. 2,412 Self Help Groups (SHGs) were formed, 923 SHGs were given Revolving Fund, 4,528 candidates were skill trained and certified, 3,806 trained candidates were given placement, 1,254 beneficiaries were assisted with loans for setting up of individual and micro enterprises, and 1,266 loans were given to SHGs under SHG-Bank linkage programme.

V. Pradhan Mantri Awas Yojana (PMAY)/ Housing for All (HFA)

i. A total of Rs. 340.04 crore has been released during the month.

ii. 81.03 lakh dwelling units in 16,373 projects with an investment of Rs. 4,82,829 crore involving Central assistance of Rs. 1,26,118 crore have been approved under PMAY. So far, 46,85,285 houses have been grounded for construction, 25,79,482 houses have already been constructed and 23,81,022 houses have been occupied.

VI. NBCC(India)

i. NBCC signed a MoU for the Construction of Second Campus of Ravenshaw University in Cuttack, Odisha.

VII. RERA

i. With notification of Rules by Mizoram and Manipur, now 30 States/ UTs have notified RERA Rules. Jammu & Kashmir has notified its own Act on the lines of RERA and also the Rules.

ii. Four North-Eastern States viz. Sikkim, Meghalaya, Arunachal Pradesh and Nagaland are yet to notify the Rules for which they are being pursued vigorously.

iii. State of West Bengal has notified its own law called Housing Industry Regulation Act which has been challenged in the Supreme Court. This Ministry has submitted its affidavit for annulment of the Act.

iv. So far, 41,680 housing projects and 31,610 real estate agents have been registered under RERA.
