

## **Annexure**

A summary of important policy decisions/ events pertaining to the Ministry of Housing and Urban Affairs during the month of April, 2024 is given below:

### **I. Swachh Bharat Mission (Urban)**

Two round table discussions were organized on 5.04.2024 and 23.04.2024 on “Global Best Practices in Municipal Solid Waste Management” to improve Waste Management in India. Representatives from Industries, international agencies, civil society and thematic experts have participated in the discussions.

### **II. Smart City Mission**

- “Happiness Park” has been unveiled on 11.04.2024 in Lucknow Smart City. It is a recreational space for children and families to relax and enjoy.
- The Raipur Municipal Corporation organized a ‘Startup Summit’ on 20.04.2024 to promote startups and connect youth with employment-oriented programs, in which young entrepreneurs provided information about their industrious efforts in preparing businesses and institutional activities.
- 69 projects worth Rs. 284 crore were completed during the month.

### **III Atal Mission for Rejuvenation and Urban Transformation (AMRUT)**

#### **AMRUT**

- i. 42 projects worth Rs. 1,569 crore got completed during the month.
- ii. Total works worth Rs. 465 crore were executed in the month.

## **AMRUT 2.0**

- i. Detailed Project Reports (DPR) approved for 287 projects costing of Rs.876 core.
- ii. Notice Inviting tender (NIT) has been issued for 257 projects costing of Rs.1,000 crore.
- iii. Contract for 407 projects costing of Rs. 7,703 crore have been awarded.
- iv. AMRUT Mitra, an initiative was launched under AMRUT 2.0. to actively involve women SHG groups in water sector. This initiative emphasizes upon involvement of women in works such as water quality testing, park maintenance, bill collection/ distribution, maintenance of WTPs/ STPs/ FSTPPs, etc. During the month, proposals received from 13 states of 304 projects worth Rs. 50.43 crore were approved.

### **IV. Deendayal Antyodaya Yojana / National Urban Livelihood Mission (DAY/NULM)**

During the month 1,522 Self Help Groups (SHGs) were formed. 534 beneficiaries were assisted with loans for setting up of individual and micro enterprises and 21 numbers of loans were given to SHGs under SHG-Bank linkage programme.

### **V. PM Street Vendor's Atma Nirbhar Nidhi (PM SVANidhi)**

Under PM SVANidhi, 1,07,40,320 applications were received against which 88,56,270 sanctions and 84,63,348 loans disbursement have been made till April 2024.

### **VI. Pradhan Mantri Awas Yojana (PMAY)/ Housing for All (HFA)**

- i. Since the inception, Mission has sanctioned 1.19 crore houses of which 114.22 lakh houses have been grounded for construction of which 83.01 lakh houses have been completed/ delivered.
- ii. Rs. 0.44 crore were released during the month taking cumulative to Rs.1,63,926 crore since inception i.e., June 2015.

## **VII. Housing**

Progress made under Real Estate (Regulation & Development) Act 2016 in the month:

- 691 Real Estate Projects were registered
- 500 Real Estate Agents were registered
- 770 Complaints were disposed-off by different Real Estate Regulatory Authorities

## **VIII. Central Public Works Department (CPWD)**

- i. Vigilance Unit organized 3<sup>rd</sup> Interactive Session to make aware and sensitise CPWD field officials to avoid lapses of repetitive nature on April 19, 2024 at Hyderabad.
- ii. Workshop on Enterprise Resource Planning (ERP) implementation were organized in CPWD at Madurai from 03.04.2024 to 05.04.2024 and in Guwahati from 24.04.2024 to 26.04.2024.
