Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of July, 2022

#### I. Swachh Bharat Mission

- i. All 4,372 cities/ towns have been declared as ODF (Open Defecation Free) of which 4,325 cities have been certified through third party verification, 3,447 cities have been certified as ODF+, 1062 cities have been certified as ODF++ and 9 cities have been certified as Water+.
- ii. 67,407 toilets across more than 3,326 cities are live on Google Maps with the name of "SBM Toilet".
- iii. Swachhata App emerged as an important tool towards enabling citizens to have their grievances addressed by the concerned Municipal Corporation. The revised version enables citizens to get their COVID-related complaints also redressed by their respective ULBs. The Swachhata App has a total of 2.08 crore users, who have posted 2.55 crore complaints, of which 2.39 crore complaints have been resolved, with a resolution of above 94%.
- iv. Swachh Technology Challenge was launched by SBM-U, MoHUA on 6th Dec 2021, as part of Swachh Survekshan 2022 indicator. To further incentivize the start-up ecosystem, SBM-U, MoHUA also launched a Swachhata Start-Up Challenge as next step to the Swachh Technology Challenge on 27th January 2022, in partnership with AfD (Agence Française de Développement), France. Winning solutions from start- ups under Swachh Technology Challenge were to participate in the Swachhata Start-Up Challenge. A total of 236 solutions across four themes viz, (i) social inclusion, (ii) zero dump (solid waste management), (iii) plastic waste management and (iv) transparency through digital enablement were received, of which 30 solutions have been shortlisted. Out of the shortlisted solutions the final list of 10 winners will be chosen by a jury. Winning entries under the Challenge will be rewarded with seed funding of ₹25 lakhs per project along with one year of dedicated incubation support.
- v. The fourth episode of SwachhTalks was held on 28.07.2022 on the topic of "Managing Plastic Waste". The aim of this episode was to nudge discussions around the need to effectively manage plastic waste to achieve the Mission's goal of creating "Garbage Free Cities".
- vi. On 26<sup>th</sup>July, 2022 representative from MoHUA participated and provided his inputs in a one-day conference titled "Legacy Waste Management Challenges and Way Forward" in Bengaluru held by Directorate of Municipal Administration, Government of Karnataka. The objective of the conference was to bring together government officials, sector experts, technical experts, and other relevant stakeholders on one forum to discuss how Karnataka can remediate its dumpsites.
- vii. On behalf of Government of Maharashtra, State Mission Directorate Swachh Bharat Mission hosted a one-day workshop on 23rd July 2022 chaired by team of MOHUA officials. The agenda of one day workshop was an interactive handholding session on City Sanitation Action Plan (CSAP) and City Solid Waste Action Plan (CSWAP)

viii. To sensitize the ULBs on Swachh Bharat Mission (Urban) scheme and its various components, regional one day orientation programs were organized at 3 regions of Kerala.

#### II. Smart Cities Mission (SCM)

- i. During the month 155 projects worth ₹ 2,229 crore have been completed, work has been started on 9 projects worth ₹ 202 crore. So far 7,649 projects worth ₹1,81,574 crore have been grounded and 4,177 projects worth ₹ 68,523 crore have been completed.
- ii. The first Orientation Workshop for Urban Outcomes Framework 2022 was organized in Ranchi Smart City on 29 July 2022. The Urban Outcomes Framework (UOF) 2022 aims to create a cross-sectoral urban data bank based on city outcomes.
- iii. A tripartite MoU was signed between MoHUA, Government of Maharashtra and National Institute of Urban Affairs (NIUA), to ease online delivery of municipal services in the country and the National Urban Digital Mission (NUDM).
- iv. Healthy Street Capacity Development Workshop was organized by Smart Cities Mission in partnership with ITDP India, Directorate of Urban Land Transport (DULT) Karnataka and Bengaluru Smart City. The 2 days workshop focused on how cities can accelerate their walking and cycling transformation through presentations, panel discussions and site visits in Bengaluru.

# III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

- i. State Annual Action Plans (SAAPs) have been finalized for all the states for ₹77,640 crore. As on date, Detailed Project Reports (DPRs) have been approved for the projects costing ₹83,015 crore. Some States have taken up projects in excess of their approved SAAPs. Entire excess amount in such cases will be borne by the States/ULBs. Works have been completed for 4,517 projects worth ₹29,810 crore and work is in progress for 1,345 projects worth ₹52,532 crore. In all, physical work worth about ₹64,388 crore has been carried out in completed/ongoing AMRUT projects implying that around 83% of physical work has been completed.
- ii. So far, ₹37,493 crore has been released to States/UTs towards project implementation (including the eligible projects of erstwhile JnNURM), Administrative & Office Expenses (A&OE), reform incentive, and under subschemes on 'Formulation of GIS based Master Plans in AMRUT cities' and 'Local Area Plan (LAP) and Town Planning Schemes (TPS)' in 25 selected cities.

### IV. Deendayal Antyodaya Yojana /National Urban Livelihood Mission (DAY/NULM)

 15,094 Self Help Groups (SHGs) have been formed; 7,159 SHGs were given Revolving Fund; 17,485 candidates were skill trained and certified; 3,659 trained candidates were given placement; 13.172 beneficiaries were assisted with loans for setting up of individual and micro enterprises and 11,795 loans were given to SHGs under SHG-Bank linkage programme.

# V. PM Street Vendor's AtmaNirbhar Nidhi (PMSVANidhi)

- i. Under PM Street Vendor's AtmaNirbhar Nidhi (PMSVANidhi), 54,13,991 applications have been received against which 37,55,378 sanctions and 34,14,042 disbursals have been made.
- ii. A cultural festival for celebrating the success of PM SVANidhi scheme and also to honour the contribution of street vendors towards the Indian economy was organized by MoHUA from 9<sup>th</sup> July to 31<sup>st</sup> July, 2022, in 75 select across the country, as part of Azadi Ka Amrut Mahotsav.

# VI. Pradan Mantri Awas Yojana (PMAY)/Housing for All (HFA)

- i. Hon'ble Prime Minister reviewed the live progress of the work of the Light House Projects (LHPs) at Agartala (Tripura), Ranchi (Jharkhand), Indore (Madhya Pradesh), Lucknow (Uttar Pradesh) and Rajkot (Gujarat) under Global Housing Technology Challenge-India (GHTC-India) through HD live videography on 20.07.2022.
- ii. Since the inception, Mission has sanctioned 1.23 crore houses of which 101.43 lakh houses have been grounded for construction of which 61.04 lakh houses have been completed/delivered.

#### VII. Housing

- i. All States/ UTs have notified rules under RERA except Nagaland, which is under process to notify the rules.
- ii. 31 States/UTs have set up Real Estate Regulatory Authority (Regular 25, Interim - 06). Ladakh, Meghalaya, Sikkim & West Bengal have notified the rules while yet to establish authority.
- iii. 28 States/UTs have set up Real Estate Appellate Tribunal (Regular -24, Interim 04).
- iv. Regulatory Authorities of 28 States/UTs have operationalized their websites under the provisions of RERA.
- v. So far, 97,576 complaints (including 1,673 complaints during the month) have been disposed of by the Real Estate Regulatory Authorities across the country
- vi. So far, 87,239 projects and 65,639 agents have been registered under RERA. 1,849 projects and 670 agents have been registered during the month.
