# Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of February, 2018

#### I. Swachh Bharat Mission

- 1. 1,824 cities/towns, including 100 cities/towns during the month, have been declared Open Defecation Free (ODF) so far through third party certification.
- 2. 75.29 lakh citizens are registered on the Swachhata App. 1.23 crore complaints were registered and 1.17 crore complaints were resolved. The app has a resolution rate of 94.6%. During the on-going Swachh Survekshan, 2018, the App is also serving as one of the platforms for citizens to provide feedback on their city's cleanliness.
- 3. Alongside the assessments for Swachh Survekshan, 2018 being carried out in all 4,041 cities, the officers of the Ministry of Housing and Urban Affairs have visited the cities as assessment observers to evaluate whether the assessments are being carried out impartially and as per the guidelines in Swachh Survekshan protocol.

#### **II.** Smart Cities Mission

88 Smart Cities have incorporated city level Special Puropose Vehicles (SPVs) till date. Two cities of Round 3 namely Gangtok and Bangaluru incorporated SPVs in the month of February, 2018

# III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

- State Annual Action Plans (SAAPs) have been finalized for all the States to the tune of Rs. 77,640 crore (4,672 projects).
   333 projects worth Rs. 232 crore have been completed and in case of 1,789 projects worth Rs. 35,167 crore, work is in progress. 1,915 projects worth Rs. 23,424 crore are under tendering.
- ii. A National Orientation Workshop on Livability Indices was held on 13 February, 2018 at Vigyan Bhawan, New Delhi

## IV. Pradhan Mantri Awas Yojana (PMAY)/ Housing for All (HFA)

- i. Raising of funds through Extra Budgetary Resources (EBR) to the extent of Rs. 60,000/- crore through lending agencies or financial institutions, over four year for PMAY (Urban) projects was approved by the government.
- ii. Release of Central grant for the States of Gujarat, Haryana, Maharashtra, Odisha, Karnataka, Tamiinadu, Kerala, Bihar and Uttarakhand was approved
- iii. 40.62 lakh dwelling units in 8,341 projects with an investment of Rs. 2,25,219/- crore involving Central assistance of Rs. 62,464 crore have been approved. So far, 20.80 lakh houses have been grounded for construction, 3.39 lakh houses have been constructed and 2.97 lakh houses have been occupied.
- iv. Rs.122.08 crore was released to the States during the month.

## V Deendayal Antyodaya Yojana / National Urban Livelihood Mission (DAY/NULM)

- i. Fourth meeting of Governing Council under DAY-NULM was held on 02.02.2018 under the Chairmanship of Hon'ble MoS(IC) HUA, to give broad direction to the Mission
- ii. Review of the progress of all State/UTs under DAY-NULM was done through three video conferences held on 09.02.2018, 19.02.2018 and 21.02.2018.
