Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of November, 2021.

I. Swachh Bharat Mission (SBM)

- i. 4,369 cities/ towns have been declared as ODF (Open Defecation Free) out of which 4,295 cities have been certified through third party verification. 3,330 cities have been certified as ODF+ and 961 cities have been certified as ODF++ and 9 cities have been certified as Water+.
- ii. Digital Platform was developed by MoHUA for Monitoring of Community and Public Toilets (CT/PTs). This platform will enable citizens to provide feedback on the cleanliness of the CT/PTs. As on date, 1.19 lakh feedbacks were received from more than 8,105 CP/PTs across the country. 3,566 ULBs are leveraging the QR code.
- iii. 66,020 toilets across more than 3,296 cities are live on Google Maps with the name of "SBM Toilet". The process of uploading SBM toilets on Google maps has been updated.
- iv. Swachhata App emerged as an important tool to handle queries specific to Covid 19. The revised version enables citizens to get their COVID-related complaints also redressed by their respective ULBs. The Swachhata App has a total of 1.82 crore users, who have posted 2.39 crore complaints, of which 2.24 crore complaints have been resolved, with a resolution of above 93.72%.
- v. The number of cities with 7-Star Certification is 72, 5-Star Certification is 291, 3-Star Certification is 796 and 1-Star Certification is 1,079 under Star Rating Protocol for Garbage Free Cities.
- vi. Hon'ble President of India graced 'Swachh Amrit Mahotsav' and presented Swachh Survekshan 2021 awards at a function hosted by the Ministry of Housing and Urban Affairs (MoHUA) at Vigyan Bhavan, New Delhi on 20th November 2021. 7 cities (Indore, Surat, Vijayawada, Vita, Lonavala, Saswad, and Varanasi), 2 States (Chhattisgarh and Jharkhand), and 1 Cantonment Board (Ahmedabad Cantt.) received Swachh Survekshan 2021 and Safaimitra Suraksha Challenge awards from the Hon'ble President. More than 300 awards under various categories under Swachh Survekshan 2021, Safaimitra Suraksha Challenge, and certifications for garbage-free star rating for cities were awarded to the respective cities and States.

II. Smart Cities Mission (SCM)

- i. During the month 37 projects worth ₹ 309 crore have been completed and work has been started on 59 projects worth ₹ 1,399 crore. So far 6,492 projects worth ₹ 1,86,127 crore have been tendered, work orders have been issued for 5,861

projects worth ₹1,57,564 crore out of which 3,170 projects worth ₹53,370 crore have been completed.

III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

- i. State Annual Action Plans (SAAPs) have been finalized for all the states for ₹77,640 crore. As on date, Detailed Project Reports (DPRs) have been approved for the projects costing ₹81,894 crore. Some States have taken up projects in excess of their approved SAAPs. Entire excess amount in such cases will be borne by the States/ULBs. Works have been completed for 3,883 projects worth ₹22,430 crore, work is in progress for 1,935 projects worth ₹58,284 crore. In all, physical work worth about ₹57,414 crore has been carried out in completed/ongoing AMRUT projects implying that around 74% of physical work has been completed.
- ii. So far, ₹35,221 crore has been released to States/UTs towards project implementation (including the eligible projects of erstwhile JnNURM), Administrative & Office Expenses (A&OE), reform incentive, and under sub-schemes on 'Formulation of GIS based Master Plans in AMRUT cities' and 'Local Area Plan (LAP) and Town Planning Schemes (TPS)' in 25 selected cities.
- iii. A National level launch cum workshop of 'Association of Water Supply and Sanitation Organisations (AWSSAR)' was organised by MoHUA on 27th November, 2021 at Bhubaneswar.

IV. Deendayal Antyodaya Yojana-National Urban Livelihood Mission (DAY-NULM)

- i. 11,032 Self Help Groups (SHGs) have been formed; 6,252 SHGs were given Revolving Fund; 10,004 candidates were skill trained and certified; 6,473 trained candidates were given placement; 15,817 beneficiaries were assisted with loans for setting up of individual and micro enterprises and 24,501 loans were given to SHGs under SHG-Bank linkage programme.
- ii. Under PMSVANidhi, 49,61,796 applications have been received against which 30,22,920 sanctioned and 26,73,864 disbursements have been made.
- iii. A total of ₹ 80.007 crore under PM SVANidhi scheme have been released during the month.

V. Pradhan Mantri Awas Yojana (PMAY)/Housing for All (HFA)

- i. Since the inception, Mission has sanctioned 1.14 crore houses of which 89.62 lakh houses have been grounded for construction of which more than 52.88 lakh houses have been completed/delivered.
- ii. A total of ₹ 18.18 crores have been released under PMAY-U 'Housing for All' mission during the month.

VI. Housing

- i. All States/ UTs have notified rules under RERA except Nagaland which is under process to notify the rules.
- ii. 30 States/UTs have set up Real Estate Regulatory Authority (Regular - 25, Interim - 05).
- iii. 28 States/UTs have set up Real Estate Appellate Tribunal (Regular -24, Interim – 04).
- iv. Regulatory Authorities of 27 States/UTs have operationalized their websites under the provisions of RERA.
- v. So far, 78,986 complaints (including 1,686 complaints during the month) have been disposed of by the Real Estate Regulatory Authorities across the country.
- vi. So far, 71,565 real estate projects and 56,236 real estate agents have been registered under RERA . 1,331 real estate projects and 886 real estate agents have been registered during the month.
