



## Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of June, 2022

### I. Swachh Bharat Mission

- i. In order to ensure effective management of plastic waste, along with enforcement of the ban on manufacture, import, stocking, distribution, sale and use of Single Use Plastic (SUP) less than seventy-five microns ( $75 \mu$  i.e. 0.075 mm in thickness), a number of initiatives have been undertaken by MoHUA under the ambit of SBM-U like:-
  - i. Advisories have been sent to all States/ UTs with a suggested list of initiatives that could be taken to enforce the SUP ban by 30<sup>th</sup> June, 2022, to ensure effective plastic waste management. The advisories have suggested large scale plogging drives, with special emphasis on plastic waste collection and awareness regarding ban on SUP, with participation of all citizens – students, voluntary organizations, self-help groups, local NGOs/CSOs, NSS and NCC cadets, RWAs, market associations, corporate entities, etc.
  - ii. SBM-Urban 2.0 launched a nation-wide social media campaign 'Clean Green Campaign' as a run up to World Environment Day on 5<sup>th</sup> June, 2022 to spread awareness regarding the need for swachhata, proper waste management, as well as the SUP to be in effect from 1<sup>st</sup> July, 2022. Due to relentless follow-ups with city and State officials 94.5% of Urban Local Bodies, or 4445 Urban Local Bodies from across 34 States and UTs, notified the SUP ban during the campaign period.
- ii. All 4,372 cities/ towns have been declared as ODF (Open Defecation Free) of which 4,325 cities have been certified through third party verification, 3,447 cities have been certified as ODF+, 1062 cities have been certified as ODF++ and 9 cities have been certified as Water+. Revised Swachh Certification Protocols for ODF, ODF+, ODF++, and Water+ certifications were launched at an event, held at Nirman Bhawan, New Delhi, chaired by Secretary (MoHUA).
- iii. 67,407 toilets across more than 3,326 cities are live on Google Maps with the name of "SBM Toilet".
- iv. Swachhata App emerged as an important tool towards enabling citizens to have their grievances addressed by the concerned Municipal Corporation. The revised version enables citizens to get their COVID-related complaints also redressed by their respective ULBs. The Swachhata App has a total of 2.08 crore users, who have posted 2.55 crore complaints, of which 2.39 crore complaints have been resolved, with a resolution of above 94%.
- v. Swachh Technology Challenge was launched by SBM-U, MoHUA on 6th Dec 2021, as part of Swachh Survekshan 2022 indicator. To further incentivize the start-up ecosystem, SBM-U, MoHUA also launched a Swachhata Start-Up

Challenge as next step to the Swachh Technology Challenge on 27th January 2022, in partnership with AfD (Agence Française de Développement), France. Winning solutions from start-ups under Swachh Technology Challenge were to participate in the Swachhata Start-Up Challenge. A total of 236 solutions across four themes viz, (i) social inclusion, (ii) zero dump (solid waste management), (iii) plastic waste management and (iv) transparency through digital enablement were received, of which 30 solutions have been shortlisted. Out of the shortlisted solutions the final list of 10 winners will be chosen by a jury. Winning entries under the Challenge will be rewarded with seed funding of ₹25 lakhs per project along with one year of dedicated incubation support

- vi. The third episode of SwachhTalks, titled "Swachh Certifications: The Face of Urban Transformation", aimed to build the capacities of officials on unique and innovative toilet solutions being deployed by cities, states, and organizations was held on 24.06.2022.
- vii. With the key intent of promoting Swachhata across Tirth Yatras, MoHUA deputed a central team to conduct a comprehensive field visit in the UT of Jammu and Kashmir and Uttarakhand State with the objective of assessing the status of preparations for the Amarnath Ji and Kedarnath.

## II. Smart Cities Mission (SCM)

- i. During the month 95 projects worth ₹ 1,580 crore have been completed, work has been started on 10 projects worth ₹ 73 crore. So far 7,650 projects worth ₹1,81,112 crore have been grounded and 4,023 projects worth ₹ 66,220 crore have been completed.
- ii. 100 Indian Smart Cities celebrated the 7<sup>th</sup> Anniversary of the Smart Cities Mission on 25 June 2022. Cities organized more than 300 events to mark the day. These events included- Plantation Drive, Ideathons, Essay competition, Climate Awareness Campaigns, Women Cycling Rally, Integrated Command Control Centre tour, Placemaking Marathon, Cultural evening, and other events. Over 20,000 citizens participated in these events. On this day, Integrated Command Control Centers (ICCC) were commissioned across four Indian Smart Cities viz. Shimla, Dharamshala, Puducherry and Guwahati with citizen services such as surveillance, eGov etc. These cities are committed to augmenting these services with improved infrastructure soon to effectively cater to the citizens' requirements.
- iii. To mark the key initiatives of the Ministry towards achieving the urban climate goals, Sh. Hardeep Singh Puri, Hon'ble Minister of Housing and Urban Affairs launched the practice-based learning program 'Leaders in Climate Change Management' on 6 June 2022. The program is designed jointly by the National Institute of Urban Affairs (NIUA), World Resources Institute India (WRI), United Nations Environment Program (UNEP) and the Indian School of Business (ISB) with the support of SCM.
- iv. Transport 4 All Challenge is an initiative of the MoHUA led by SCM that aims to bring together cities, citizens and startups to develop technology led solutions

that will improve urban mobility and public transport. 46 cities have been shortlisted in stage-1 of the challenge and move into stage-2 of the challenge where the selected cities will work with startups to develop solutions for problems in areas such as service monitoring and planning, passenger information systems, fare products and payment mechanisms.

### **III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)**

- i. State Annual Action Plans (SAAPs) have been finalized for all the states for ₹77,640 crore. As on date, Detailed Project Reports (DPRs) have been approved for the projects costing ₹83,030 crore. Some States have taken up projects in excess of their approved SAAPs. Entire excess amount in such cases will be borne by the States/ULBs. Works have been completed for 4,318 projects worth ₹29,014 crore and work is in progress for 1,539 projects worth ₹53,315 crore. In all, physical work worth about ₹63,821 crore has been carried out in completed/ongoing AMRUT projects implying that around 82% of physical work has been completed.
- ii. So far, ₹37,491 crore has been released to States/UTs towards project implementation (including the eligible projects of erstwhile JnNURM), Administrative & Office Expenses (A&OE), reform incentive, and under sub-schemes on 'Formulation of GIS based Master Plans in AMRUT cities' and 'Local Area Plan (LAP) and Town Planning Schemes (TPS)' in 25 selected cities.
- iii. An "Online Training for Projects Monitoring Module in AMRUT 2.0 portal" was organized by MoHUA for States/ULBs.
- iv. An "Online Workshop on Pey Jal Survekshan under AMRUT 2.0" was organized by MoHUA for States/ULBs.

### **IV. Deendayal Antyodaya Yojana /National Urban Livelihood Mission (DAY/NULM)**

- i. 12,131 Self Help Groups (SHGs) have been formed; 4,625 SHGs were given Revolving Fund; 15,507 candidates were skill trained and certified; 1986 trained candidates were given placement; 8,936 beneficiaries were assisted with loans for setting up of individual and micro enterprises and 8,958 loans were given to SHGs under SHG-Bank linkage programme.
- ii. On 20.06.2022, Hon'ble Minister of Housing & Urban Affairs launched an innovative project 'NIPUN' (National Initiative for Promoting Upskilling of Nirman Workers) for skilling of 1.06 lakh construction workers

### **V. PM Street Vendor's AtmaNirbhar Nidhi (PMSVANidhi)**

- i. Under PM Street Vendor's AtmaNirbhar Nidhi (PMSVANidhi), 53,67,928 applications have been received against which 36,43,176 sanctions and 33,11,577 disbursals have been made.

- ii. On 02.06.2022, meeting with India Post Payment Bank was held under the chairmanship of Additional Secretary, MoHUA to discuss the issues related to updation of mobile numbers with Aadhaar Cards at the doorstep of PM SVANidhi beneficiaries.

#### **VI. Pradan Mantri Awas Yojana (PMAY)/Housing for All (HFA)**

- i. A total of ₹ 1680.19 crores have been released under PMAY(Urban) 'Housing for All' mission during the month.
- ii. Since the inception, Mission has sanctioned 1.23 crore houses of which 101.43 lakh houses have been grounded for construction of which 61.04 lakh houses have been completed/delivered.

#### **VII. Housing**

- i. All States/ UTs have notified rules under RERA except Nagaland, which is under process to notify the rules.
- ii. 31 States/UTs have set up Real Estate Regulatory Authority (Regular - 25, Interim - 06). Ladakh, Meghalaya, Sikkim & West Bengal have notified the rules while yet to establish authority.
- iii. 28 States/UTs have set up Real Estate Appellate Tribunal (Regular -24, Interim – 04).
- iv. Regulatory Authorities of 28 States/UTs have operationalized their websites under the provisions of RERA.
- v. So far, 95,903 complaints (including 3,385 complaints during the month) have been disposed of by the Real Estate Regulatory Authorities across the country
- vi. So far, 85,390 projects and 64,959 agents have been registered under RERA. 2,829 projects and 1,437 agents have been registered during the month.
