- Note 1: A departmental candidate in the feeder grade of Assistant Secretary (Technical) in Pay Band of Rs. 15,600-39,100/- with Grade Pay of Rs. 6,600/- with ten years' regular service in the grade shall also be eligible to be considered for this post along with the outsiders and in case he is selected, his appointment shall be deemed to have been made by promotion.
